EDITORIAL Free vaccination

India's war with Corona continues and despite repeated infections returning, our determination to fight this most frightening epidemic of the century is strong. We have controlled the deaths from Corona to a large extent, it is evident from this that we are the second largest populous nation in the world but we are ranked 20th in terms of daily deaths. Talk about MP, if you leave the big cities like Indore and Bhopal and the areas around them, then the corona is under control in the rest of the state and the pace of infection has decreased. Regulate pricing of printer-cartridges and standardise for drastic cut in prices

Largest-selling foreign company Hewlett-Packard (HP) marketing computer-printers in Indian market has Maximum-Retail-Price printed on ink-cartridges exorbitantly high even though its original cartridges available in wholesale markets of Nehru place and Nai Sarak in Delhi at much-much less than printed MRP.

Even wholesale price for its inkcartridges remains much higher around rupees 3000 making some Indian manufacturers marketing re-filled cartridges at around rupees 700 or so.

Even re-fill can be done at just rupees 200 or so. But using re-filled ink-cartridges result in termination of warranty.

CRISPR could turn genes on and off with help of nanobodies

Researchers from Stanford during an experimental combo designed to extend the efficacy of two promising molecular tools, attached biological nanobodies to the CRISPR DNA editing tool. The genetic tool, CRISPR has been likened to molecular scissors for its

ability to snip out and replace genetic code within DNA. The study was published in the Journal of Nature Communications. CRISPR has the capability that could make it useful barrand genetic remains

CRISPR has the capability that could make it useful beyond genetic repairs. "CRISPR can precisely locate specific genes," said Lacramioara Bintu, an assistant professor of bioengineering at Stanford. "What we did was attach CRISPR to nanobodiesto help it perform specific actions when it reached the right spot on DNA." Her lab recently used this combo technique to transform CRISPR from gene-editing scissors into a nanoscale control agent that can toggle specific genes on and off, like a light switch, to start or stop the flow of some healthrelated protein inside a cell. "There are a lot of things you can't fix with coissors in the powel technique her team describes in the journal scissors," Bintu said. The novel technique her team describes in the journal Nature Communications could enable researchers to explore new therapeutic applications in the field of epigenetics — which is the study of how genes beĥave inside cells.

YouTube's new feature will allow parents to choose what children can watch

Online video-sharing platform YouTube is launching a new feature that would let parents control what their childrencan watch. As per The Verge, YouTube's upcoming feature called 'supervised experiences', will come with a new set of restrictions that allows parents to better control what content their children can access on the video platform.

According to a blog post, YouTube hopes that the filter will help parents slowly introduce their older children to age-appropriate content and features outside of the YouTube Kids

app. The mode will launch first with an early beta, with a wider beta rolling out in the coming months.

Parents have three levels of strictness to choose from, which determines the content a child is allowed to view on their account. There is the 'Explore' level, which YouTube said is "generally suitable" for kids nine and up. 'Explore More', which is meant for kids 13 and up, and 'Most of YouTube', which is pretty much everything except age-restricted content. In the US, and most other countries, people over the age of 13 can make their own unsupervised YouTube accounts.
